With reference to the captioned subject, we would like to inform you that the Company has received an order from the office of the Deputy Commissioner of State Tax, Pune, LTU-2 imposing penalty u/s 73 of the CGST Act, 2017 amounting to Rs. 40,000/- w.r.t certain minor discrepancies in Input Tax Credit (ITC) claims arising out of vendor non-compliance. This order is issued against erstwhile Mahindra Vehicle Manufacturers Limited, which has since been merged with the Company.

Based on the Company's assessment, an appeal will be filed, and the Company is hopeful of a favourable outcome at the appellate level and does not reasonably expect the said Order to have any material financial impact on the Company.
